EVENT HOURS: Set up will be available on Friday, September 21, 2011 between the hours of 10:00am-4:00pm. Show opens at 10:00am on Saturday, September 22, 2011. Vehicles will not be allowed within the venue between the hours of 9:00am and 4:30pm day of event. All booths are expected to remain open until 4:30pm.

EXHIBIT DISPLAY: All displays should be presented in a professional manner. All tables should be neatly covered and in good condition. **NO SALE OR DISCOUNT BANNERS.**
